

## **PRIZE DRAW TERMS AND CONDITIONS**

### **Skoda Prize Draw Terms and Conditions**

1. By entering the prize draw ("**the Prize Draw**"), you confirm your acceptance of the following terms and conditions (the "**Terms**"). These Terms apply to the Prize Draw defined below.
2. The promoter of this Prize Draw is Volkswagen Group United Kingdom Limited trading as Skoda UK (Company Number 00514809) whose registered office is at Yeomans Drive, Blakelands, Milton Keynes, MK14 5AN (the "**Promoter**").
3. You will be legally bound by these Terms from the time you submit an entry to the Prize Draw, so please read them carefully before entering.

#### **CAN I ENTER THE PRIZE DRAW?**

4. The Prize Draw is open to individuals who:
  - (a) are residents of the United Kingdom (excluding Northern Ireland);
  - (b) are aged eighteen (18) years or over;

at the time of entry into the Prize Draw and at the time of notification of the Winner (defined below). Each such individual is an "**Entrant**" for the purpose of these Terms.

5. Entry into the Prize Draw is free. No payment is necessary.
6. Participating Retailers only and subject to availability of test drive appointments.
7. The Prize Draw is not open to employees of Volkswagen Group United Kingdom Limited, their agents or contractors, Volkswagen Group brand retailers and anyone else connected with the Promotion or to their immediate family members or persons living in the same household, whether or not related, or anyone else otherwise professionally connected with the Promotion.
8. The Promoter reserves the right to verify the eligibility of any Entrant and Winners and their compliance with these Terms. The Promoter may require such information as it considers reasonably necessary for this purpose. The Promoter may withhold prizes while it verifies eligibility.
9. Internet access, a mobile phone and an email address are required to enter the Prize Draw.

#### **HOW TO ENTER**

10. The Prize Draw will open for entries at 09:00 (GMT + 0) on 01/04/2025 and will close for entries at 00:00 (GMT + 0) on 30/04/2025 (the "**Prize Draw Period**").
11. To enter, Entrants must do the following during the Prize Draw Period:
  - (a) book and take a test drive of the new all – electric Elroq or Enyaq with a Participating Retailer;
  - (b) scan the QR code found in the vehicle;

- (c) complete the online form linked to the QR code;
- (d) click "submit" and accept these terms and conditions.

## **RESTRICTIONS ON ENTRY**

12. Only entries completed and received by the Promoter during the course of the Prize Draw Period and in accordance with these Terms will be eligible for entry into the Prize Draw. No responsibility can be accepted for entries not received for whatever reason.
13. Only one (1) entry per person. Participants who seek to submit entries above this limit will be disqualified. Multiple entries or entries made through agents, third parties, organised groups or any entry duplication method will not be accepted.
14. The Promoter reserves the right to exclude any entrant from the Prize Draw in the event of a rule being breached.
15. Your entry must be completed correctly and be received during the Prize Draw Period to be eligible for the Promotion.

If a Winner cannot be contacted or does not claim their Prize within two (2) working days of notification after reasonable efforts by the Promoter, that Winner is not eligible for the Prize or has not complied with the Terms, the Promoter reserves the right (at its sole discretion) to withdraw the Prize from that Winner and pick a replacement Winner. ## **WINNERS AND PRIZES**

### *General*
